Discussion was held on salary increases.

Commissioner Schenk moved to approve the Adult Misdemeanor Probation FY21 budget of \$934,520.00 as presented with both counties sharing an equal \$251,010.00 and remainder made up with revenues with a second voiced by Commissioner Koyle. Motion carried.

Cassia County Commissioner Beck called for approval of the budget for Adult Misdemeanor Probation for FY21 of \$934,520.00 with both counties sharing an equal \$251,010.00 with remainder made up with revenues.

Commissioner Kunau voted aye and Commissioner Searle voted aye. Motion carried.

Cassia Commissioner Kunau moved to accept the Mini-Cassia Criminal Justice Center budget of \$3,733,402.00 with Cassia's portion being \$960,949.00 with a second voiced by Commissioner Searle. Motion carried.

Commissioner Koyle moved to approve the Mini-Cassia Criminal Justice Center of \$3,733,402 with Minidoka's portion being \$603, 400. With balance made up by revenues with a second voiced by Commissioner Schenk. Motion carried.

Commissioner Koyle moved to approve the FY21 Juvenile Probation budget of \$793, 311.00 with both counties' portion being \$207,723.52 with balance made up by revenues with a second voiced by Commissioner Schenk. Motion carried.

Cassia Commissioner Searle moved to approve the FY 21 Juvenile Probation of \$793,311 with both counties' portion being \$207,723.52 with balance made up by revenues with a second voiced by Commissioner Kunau. Motion Carried.

Commissioner Schenk moved to approve the FY21 Juvenile Detention budget of \$1,184,701.00 with Cassia's portion being \$490,452.51 and Minidoka's portion being \$619,903.20 as presented with a second voiced by Commissioner Koyle. Motion carried.

Commissioner Searle moved to approve the FY21 Juvenile Detention budget of \$1,184,701.00 with Cassia's portion being \$490,452.51 and Minidoka's portion being \$619,903.20 as presented with a second by Commissioner Kunau. Motion carried.

Cassia Commissioner Searle moved to approve the proposed FY21 budget for the Joint Powers Public Defender of 924,597.00 with Cassia's portion being \$466,335.12 and Minidoka's portion being \$408,261.88 with s second voiced by Commissioner Kunau. The total Budget is \$924,597. with remaining budget to be split is \$874.597.00. Motion carried.

Commissioner Koyle moved to approve the joint powers public defender FY21 proposed budget of \$924,597 with Cassia's portion being \$466,335.12 and Minidoka's portion being \$408,261.88. The total Budget is \$924,597. with remaining budget to be split is \$874.597.00. with a second voiced by Commissioner Schenk. Motion carried.
