

MINUTES
Mini-Cassia Criminal Justice Center Committee Meeting
September 13, 2022
8:00 A.M.

The meeting was called to order by Prosecutor Stevenson at 8:00 A.M.

Minidoka County representatives present were: Commissioner McClellan, Sheriff Pinther, and Prosecutor Stevenson.

Cassia County representatives present were: Commissioner Searle, Prosecutor Larsen, and Undersheriff Thompson.

Others present were: Cassia County Deputy Clerk Wallace, Director Renz, JDC Director Bodily, Minidoka Deputy Clerk Ramsey, Minidoka Clerk Page and Cassia Administrator McMurray.

Sheriff Pinther **moved to approve the minutes of August 23, 2022**, with a second voiced by Commissioner Searle. Motion carried.

Criminal Justice Center – Director Renz

Director Renz reported: that there are 149 in custody: 47 Cassia, 42 Minidoka, 46 IDOC, 12 US Marshals, and 1 Twin Falls, which makes 59 beds rented; staffing is down 3 and going to lose one more to patrol; June IDOC billing is in and will be direct deposited from now on.

Director Renz presented a rule change for #204. Commissioner Searle **moved to make the change to rule #204**, with a second voiced by Commissioner McClellan. Motion carried.

Adult Misdemeanor Probation – Director Prewitt

Director Prewitt was not present.

Juvenile Detention Center – Director Bodily

Director Bodily reported: they have 2 residents, both from Minidoka County; and down one full time male officer.

Criminal Justice Center Budget – Clerk Larsen

Deputy Clerk Wallace reported that at 95% of the year gone: Misc. Probation expenditures are at 84% and revenue is at 107%; Jail expenditures are at 90%; and the trust balance is \$483,912.13.

Juvenile Detention Center Budget – Clerk Page

Clerk Page reported that JDC is at 78.2% expended with 95% of the year gone. The trust balance is \$436,130.00.
