

OFFICIAL BRIEF STATEMENT:

The purpose for which the levy shall be used is the continued construction, repair, and maintenance of City of Burley streets and costs of equipment, materials, and personnel related thereto. The date of the election is May 17, 2022. The dollar amount estimated to be collected each year from the levy is \$165,000.00 for each of the tax years 2022 and 2023. The length of time in which the proposed levy will be assessed is two years. The estimated average annual cost to the taxpayer of the proposed levy is a tax of \$21.57 per \$100,000 of taxable assessed value, per year, based on current conditions. The proposed levy replaces an existing levy that will expire on the last day of tax year 2021, and that currently costs \$21.57 per \$100,000 of taxable assessed value. If the proposed levy is approved, the tax per \$100,000 of taxable assessed value is not expected to change from the previous year.
