QUESTION: Shall the Board of Trustees of Joint School District No. 331, Minidoka, Cassia, Jerome and Lincoln Counties, Idaho be authorized and empowered to levy a SUPPLEMENTAL LEVY in the amount of TWO MILLION, TWO HUNDRED FIFTY THOUSAND and NO/100 DOLLARS (\$2,250,000.00) per year for two (2) years, commencing with the fiscal year beginning JULY 1, 2020 and ending JUNE 30, 2022, for the purpose of financing any lawful expenses of maintaining and operating the District; all as provided in the Resolution adopted by the Board of Trustees on September 16, 2019?
